The baseline year for Gait and Motion Technology (GMT) is our financial year from 1st March 2023 to 29th February 2024 (leap year). We are a micro business with 5 full time and 1 part time staff who all work from home. Occasional travel to events and meetings is covered in the below emissions. We recognise that it is important to address the issue of climate change and strive to improve our business practices to help in the Government's Net Zero goals. Our main supplier has a detailed CFR and CRP in place which covers our manufacturing process.

Emissions reduction targets

In order to achieve Net Zero we project that carbon emissions will decrease over the next five years to 8.15 tCO₂e by 2029. This is a reduction of 20% and based on no changes to current processes. Our goal of Net Zero is to be achieved by the year 2045.

Carbon Reduction Projects

As we have only so far recorded our baseline emissions we do not have historic data for the previous year but we have already implemented the following carbon reduction strategies:

- Adopting a successful home working model, significantly reducing commuting and business travel emissions
- Where in person meetings are deemed essential, employees will be encouraged to use public transport (trains or bus).
- In the event where public transport is not practical, car sharing to all events and meetings will be encouraged
- GMTree Project established in January 2024 which plants a tree for every order of orthotics
- Energy reduction protocols turning appliances off when not in use
- Reduction in single use plastics, encouraging employees to use non disposable and end of life recyclable products at events and when home working
- Use of e-invoicing for all customers

For future projects to further reduce emissions we are planning to;

- Increase the number of electric vehicles the staff utilise
- Explore further accredited carbon offsetting initiatives for business activities we cannot avoid – until such technology is available to reduce or sequester
- Explore possibility of UK based manufacturing
